Commissioner Tom McCarthy was present to just get out to the Townships and see if there were any issues or concerns from residents that would be of interest for the Commissioners. One issue that was of concern was the utility companies working on the ditches and tearing them up but not being responsible for repairing them. Another was not sufficient signage for utility workers working on roadways and causing a dangerous situation for both motorists and workers.

Dave Brinson reported that the blood drive was very successful and the Community Building worked out very well.

Sheriff's report

Sheriff Mike Justice stopped in to the meeting to give a report about what his office has been doing. He gave a listing of statistics for the year specific to Liberty Township. He also reported about some projects the department is doing. One is called Project Life Saver which is designed to provide people with dementia bracelets that help to locate them if they are lost, this is available across multiple agencies within the County. Also there is a female firearm safety course October 4,18 and November 4. On November 8 there is a youth turkey shoot. And September 8-October 27 there is a Citizens Academy from 6-8 pm where students will talk and train interactively with deputies.

Maintenance Supervisor Jerry Welch gave report of activities for May:

They also got a grant from the USDA to pay for the expansion at the Leesburg station. Total fire runs were Leesburg-12, Liberty-12, Taylor-6, York-4, EMS Leesburg-10, Liberty-14, Taylor-7, York-6.

Zoning department report

Zoning inspector Terry Turner reported that he has received 1 application and has issued 1 permit and denied 1 permit this month but that was due to a technical difficulty. He had around 25 calls for the month, 30 incoming emails and 25 outgoing emails. The next regular meeting for the BZA will be on September 24 at 7 pm.
