# Audience questions/comment

Several residents were in attendance to express their disapproval about the solar project on SR 347 just west of Lunda Road. Hayes Ingram brought a resolution that was prepared in Washington Township that is to ask the County Commissioners to not allow any more large scale solar projects in their Township.

Karla Wygle reported that the initial work the solar company has been doing is invasive and that some of the workers are requesting access to their property without having proper credentials and refusing to say who they are.

They also as a group expressed their frustrations with the project as they just don't want that in their community regardless of how well the company claims to take care of the site. They also were frustrated in how this affects them and their property but can't seem to be able to do anything to stop it.

They were also upset that the board had met with the company to have them outline the project before having a meeting with the residents that will come later. They were mainly upset that they were not invited to this meeting. A different protocol should have been followed by the Board.

Jack McCoy made a motion to draft a resolution to the Commissioners requesting restrictions on solar projects under House Bill 52 and submit to Prosecutor's office for approval, seconded by Jerry McClary. A vote was taken- Jack McCoy-aye, Jerry McClary-aye, Mike Moffett-aye.
