Fire Department Report

Jerry McClary reported that at the last District meeting it was reported that staffing was at 100% for the previous month. He also reported that they had 5 calls for the past month with 41 of those being in the District. Work is beginning on the modifications to the firehouse at Leesburg.

Zoning department report
