Whereas the Liberty Township Zoning Commission voted unanimously to amend the Liberty Township Zoning resolution in the following sections: Section 101-Use of Land or Buildings; Section 1004 Temporary Building; Section 1067 Mobile Trailers Prohibited for Business, Storage, and Sign Purposes; Section 1130 Parking Space Requirements; Article XIII Mobile Home Parks and Mobile Homes Individually. And additionally add Section 1042 Agritourism; Section 1076 Medical Marijuana; and Section 1083 Solar Energy Systems.

Jack McCoy made a motion to adopt the amendments, seconded by Mike Moffett. A vote was taken-Jerry McClary-aye, Jack McCoy-aye, Mike Moffett-aye.

Jett Regula came to the meeting to show his appreciated the repair work on the tile draining his field.
